## Emissions reduction targets

Buchanan Orthotics will publish full reduction targets through climate partners. In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. We project that carbon emissions will decrease over the next five years to 223.04 tCO<sub>2</sub>e by 2028. This is a reduction of 40 %.

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equates to a significant reduction against the 2023 baseline, and the measures will be in effect when performing the contract.

- Replacement of all company petrol vehicles with electric vehicles. This is 40% complete.
- Working towards achieving ISO14001 with initial Audit due in January 2025.
- Procuring all Electricity through renewable sources, certified as of January 2024.
- Implementing Environmental policy processes including stopping overtime and ensuring
- above 90% efficacy in machine/energy usage.
- All lighting across offices and factory have been replaced with LED bulbs as of July 2024

- Reducing travel in alignment with Environmental policy, implementing online training and
- reducing on-site visits.

In the future, we hope to implement further measures such as:

- Installation of Solar panelling on the Factory roof, which should generate 30% of the energy requirements.
